
Now imagine that you are a judge in a debate between supporters of legalizing doctor-assisted suicide and opponents of doctor-assisted suicide. Please listen to both sides of each short debate then tell me if you think the debate was won by supporters or opponents of doctor-assisted suicide.

**3a. Pain and Suffering**

Supporters of doctor-assisted suicide argue that desperate patients often request doctor-assisted suicide to avoid what would otherwise be an inevitably long, slow death.

Opponents argue that this is not an "either/or choice." They say that we must continue to do more to alleviate pain and suffering, but that if doctor-assisted suicide becomes just another treatment option, and a cheap option at that, there will be less and less focus on alleviating pain and more and more emphasis on "efficient" options like death.

Who do you believe won this debate: supporters or opponents of doctor-assisted suicide?




**3b. Right to Dignity**

Supporters of doctor-assisted suicide argue that terminally ill patients have a right to die on their own terms and with their dignity intact. Legislating doctor-assisted suicide assures them a real choice.

Opponents argue that the right to refuse medical treatment already exists and is protected in our current law. We need to protect vulnerable patients who would be at risk of being pressured to choose death by a lethal prescription. That pressure could come from an insurance company that doesn't want to pay a bill or a family member who stands to gain from the patient's death.

Who do you believe won this debate: supporters or opponents of doctor-assisted suicide?




### 3c. Insurance Influence

Opponents argue that with increasing healthcare costs will come the inevitable motivation to keep costs down by encouraging doctor-assisted suicide. What we're talking about is legalizing death by prescription which would allow insurance companies and government payers like Medi-Caid to get involved in a person's end-of-life decisions – to offer death as a cost-effective treatment. That gives patients less choice, not more.

Supporters of doctor-assisted suicide argue that such fears are simply not realistic and they call such fears a scare tactic. The real issue is simply whether this alternative should be included as part of the full scope of end-of-life care options.

### 3d. Disability

Supporters of doctor-assisted suicide argue that experience in Oregon, where doctor-assisted suicide is legal, has shown that fears about abuse or error have not materialized. More than ten years of official reports have debunked any claims of problems with the law.

Opponents of doctor-assisted suicide, including many Vermont disability rights groups, argue that reports about Oregon are unreliable since all information is provided by those involved in assisted-suicide deaths. They also note, and the state has acknowledged, it has no authority to investigate or verify whether the data on which reports are based is accurate or complete.

### 3e. Elder Abuse

Supporters of doctor-assisted suicide say that terminally ill patients should have the right to choose when and how to die. They argue that this is a compassionate choice that would permit such patients to die at the time of their choosing, surrounded by their family and loved ones.

Opponents say that the option of doctor-prescribed death would come at a time of great vulnerability in a person's life. The sad truth is that sometimes family members do not treat each other with love and respect and that if death by prescription becomes legal, some people – particularly the elderly -- could lose their lives because of pressure or persuasion.

### 3f. Safeguards

Supporters of doctor-assisted suicide say that the Vermont proposal to legalize doctor-assisted suicide has safeguards that protect patients from abuse since the patient must request the prescription for the drugs that cause death.

Opponents say that the proposed law would lead to abuse since there are no protections for the patients once the lethal drugs are prescribed. Someone who stands to gain financially for example, could force or trick a patient into taking them and nobody would ever know.
