Been in excruciating pain all day They have to do something in the next few days because I don't know how much more I can take I'm becoming an Ibuprofen junkie. I hate it but the pain is just too strong. Supper

9/18 Mon Breakfast = Pain still here. Slept some last night I feel very sluggish today, tired. This pain is wearing me down. Lunch. Supper

9/19 Tue = Breakfast, no sleep last night rough night. Got a HTC pass. Thought it might be the Dr. Chronic care. told them I can't stand the pain anymore. They took my vitals B/P 123/83 not bad. He told me all my blood work came back great. Haven't been taking my medication since I got here and had a better v up He's gonna order me some Prednisone should be here tomorrow hopefully some Ibuprofen as well. gonna try to set me up an appointment with the Dr. Had to walk all the way down to 15 building, asked the Sarge if someone could push me down in a wheel chair and he said no. Lunch, Supper

Called Jo spouted off to Jo ~~last night~~ about getting the ADA to do something about my back, also complained about the Smoking this pain is just so unbearable.

9/22 Fri

Got Ibuprofen from medical last night. Slept a little better not much. Breakfast. Had to go to Pell here this morning and get more PRO MAX = Lunch. Came back from lunch and the sarge asked me what my first name is. He's not sure, but he thinks I might be on the bus. I fucking hope so, but doubtful. Got EMAIL from BILLEN said I'm scheduled to meet with Sam on 27 = about Parole Board. Supper.

9/23 Sat.

Awake all night again, back pain real bad. Breakfast, lunch. Waiting for yard. Agony still. So much Ibuprofen, starting to ~~lose~~ scare me, not taking care of the pain. Supper.

9/24 Sun

no sleep last night, long hours in pain. Ibuprofen makes me giddy but doesn't do much for pain. Breakfast ~~with~~ ~~didn't~~ make, lunch, Supper.

9/25 Mon

Can't sleep at night Hip on fire, painful. I think it's broken. Breakfast, Well, didn't make the bus they need the list, I'm not on it. At least 5 more weeks before next bus. Maybe I'll be kicked by then. Doubt at last night shoulder acted up more than usual. Hurts my back to cough. Feels like it's breaking in half. Lunch. \$50.00 from Gigi Supper. Put MED SLIP IN LAST NIGHT

9/26 Tue

I'm about ready to do something drastic if I don't get to see someone about this pain I really getting worse

12/6/11 (Wed) about the pain. Breakfast. Went to medical. She can't do no more for me. Contacting Dr. ASAP = HAL/HPL says I have a mass on my right lung: going to schedule for a CT SCAN = TALK TO CO BLOUS He wants me to write a request to Witherite Passed staff request to C.O. BLOUS. Lunch, Supper

12/7/11 (Wed) Very painful sleeping. I think I got an hour? Breakfast. I have a HTC Pass to see Voostead, not looking forward to that. I think Voostead is lying to me. He said he hasn't seen the actual X Ray only a report. But the P.A. said she saw it and there is some kind of mass on my lung and she ordered a CT scan. I don't know, all I know is I hurt like hell. I spent three hours at medical waiting to see the Dr. and my back was in spasm when I got back so I laid down for a couple of hours and when I sat up, my whole rib cage front and back went into so much spasm I could not take more than a puff of air for 5 minutes. I thought I was going to pass out. I really got scared. He order some pain meds, so I went down to pill line and it didn't come in. Lunch, Supper

12/8/11 (Thu) = Breakfast, Went down to medical, Had 3 more X-Ray taken. Couldn't sleep at all again last night. After going to medical my back has been in Spasm ever since. Lunch, Supper, Pill line again tonight - still no pain medication

9/29 Fri - Breakfast, not much sleep last night. Getting sick of this pain

10/1 Now Comes Clinton Matthews, Roger Brown's Roommate Roger could no longer concentrate to write, nor could he sit up for any length of time

10/2 AM I HAD THE SARGEANT DECLARE A MEDICAL EMERGENCY BECAUSE ROGER WAS IN SO MUCH PAIN. I WHEELED HIM UP TO MEDICAL. WE WERE REFUSED! THE SHORT NURSE ON DUTY TOLD ROGER "CHRONIC PAIN IS NOT A MEDICAL EMERGENCY" "SHE HAD CHRONIC PAIN AND SHE COULD DEAD WITH". "IT WAS ALL IN HIS HEAD." HE WAS SCHEDULED TO SEE A DOCTOR. SHE ESPECIALLY SEEMED TO HAVE IT "IN FOR" ROGER. SHE WENT OUT OF HER WAY TO BE RUDE TO HIM EVERY TIME WE CAME UP.

10/3-

10/5 Roger continues to be in intense pain HE MOANS AND CRIES ALL NIGHT LONG. NEITHER OF US IS GETTING ANY SLEEP, HE HAS PRETTY MUCH STOPPED EATING, JUST A BITE HERE, A BITE THERE HE IS IN A WHEELCHAIR FULL TIME AND I HAVE TO HELP HIM IN AND OUT.

10/6 AM

Sargeant Pyle

I GO TO THE BUSBLE, GET THE SARGEANT TO DECLARE ANOTHER MEDICAL EMERGENCY I CANT MOVE HIM. THEY COME WITH THE AMBULANCE CART TAKE HIM UP. HE IS BACK IN A

WHEELCHAIR WITHIN A HOUR.

10/6

AFTERNOON VTDOC CASE WORKER COOBY STONE AND CAMP HILL HOSPITAL / HEALTH ADMINISTRATOR BETH HERB COME BY THE CELL TO VISIT AND SEE FOR THEMSELVES. BETH IS SO UPSET SHE WHEELS ROGER UP TO MEDICAL HERSELF TO LEAVE HIM FOR THE LONG WEEKEND FOR OBSERVATION AND EVALUATION. ROGER CLAIMED SHE REEMER THEM OUT! HE IS BACK WITHIN A HOUR. NO OVERNIGHT, NO EVALUATION. HE IS IN HUGE PAIN.

10/7 - 10/17

ROGER CONTINUES TO GO DOWN HILL. I'M FRENZIED, I CAN'T GET STAFF TO DO ANYTHING I WROTE TO BETH HERB, THE CHAPLIN EVEN AS A LAST RESORT SUPERINTENDENT HARRY. ROGER CAN

10/13

ROGER ISN'T RESPONDING WELL AT ALL CAN'T SET UP WITHOUT LOTS OF HELP COLOR HAS CHANGED ALL WEEK TO JAUNDICED. WE WENT UP FOR A TBS TEST, STAFF NURSE NOTED HIS COLOR, AND COMMENTED ON IT.

10/14

ROGER CONTINUED TO FAIL ALL DAY. HE IS DOWN TO BONES AND MOANS. I AM FRANTIC, I GET OFFICER BILOUS TO LOOK IN ON ROGER. HE AGREES AND WE MOVE HIM UP TO MEDICAL UNDER ANOTHER MEDICAL EMERGENCY. THAT IS AT 7:00 PM BY 8:00 PM WE GET HIM ADMITTED TO THE INFIRMARY. THIS IS THE LAST TIME I SAW ROGER ALIVE.

WE WERE CONTINUALLY REQUESTED AND REFUSED MEDICAL ATTENTION. TOLD REPEATEDLY IT WAS ALL IN HIS HEAD, EVEN AT THE POINT WHERE HE COULD NO LONGER STAND OR SIT UP.
